CREATIVE CUPCAKES TO COMPLETE YOUR EASTER FEAST

Moist cake, creamy frosting and chocolate-coated candies combine for a seasonal sweet that's sure to impress.

Chocolate Easter Egg Cupcakes
Recipe adapted from A Classic Twist
Prep time: 30 minutes
Cook time: 15 minutes

Cupcakes:

- 1 cup all-purpose flour
- 1 cup sugar
- 1/3 cup cocoa powder
- 1 teaspoon baking soda
- 1/2 teaspoon baking powder
- 1/2 teaspoon salt
- 1 egg, at room temperature
- 1/2 cup buttermilk, at room temperature
- 1/2 cup hot water
- 1/4 cup vegetable oil
- 1 teaspoon vanilla extract

Frosting:

- 3 sticks unsalted butter, softened and cubed
- 3 cups powdered sugar, sifted
- 2-3 tablespoons milk
- 1 teaspoon pure vanilla extract

- 1 pinch salt
- 2-3 drops brown food coloring
- egg-shaped chocolate-coated candies

To make cupcakes: Preheat oven to 350 F. Line 12-cup muffin tin with cupcake liners.

In bowl of electric mixer, sift flour, sugar, cocoa powder, baking soda, baking powder and salt.

In medium bowl, whisk egg, buttermilk, water, vegetable oil and vanilla extract.

Mix dry ingredients on low speed 1 minute. Add wet ingredients. Mix 2 minutes on medium speed and scrape sides and bottom of bowl. Mix 1 minute on medium speed.

Divide evenly among cupcake liners. Bake 12-15 minutes, or until toothpick inserted in center comes out almost clean.

Cool cupcakes on wire rack.

To make frosting: Using paddle attachment of electric mixer, whip butter 8 minutes on medium speed until pale and creamy. Add powdered sugar, milk, vanilla extract and salt; mix on low speed 1 minute. Increase speed to medium and mix 6 minutes until frosting is light, creamy and fluffy. Add food coloring and whip 1 minute.

Pipe frosting onto cupcakes and top with egg-shaped chocolate-coated candies. (Feature Impact)

Maple-Glazed Easter Ham

Recipe adapted from Southern Living

Total time: 3 hours

Servings: 10

- 1 bone-in spiral-cut ham (8-9 pounds)
- 1 cup pure maple syrup
- 1/2 cup packed dark brown sugar
- 1/2 cup (4 ounces) bourbon
- 1/2 teaspoon grated fresh ginger
- 1/4 teaspoon ground cinnamon

orange slices and wedges, for garnish
fresh rosemary sprigs, for garnish

Preheat oven to 350 F.

Place ham in large roasting pan and fill with 1/2 inch of water. Cover pan with aluminum foil and bake about 2 hours, basting every 30 minutes with juices from pan, until meat registers 120 F at thickest portion.

In medium saucepan over medium-



high heat, stir maple syrup, brown sugar, bourbon, ginger and cinnamon; bring to boil. Cook, stirring occasionally, until thickened, 6-8 minutes. Remove from heat. Cover to keep warm and set aside.

Remove ham from oven and discard foil. Increase oven temperature to 400 F.

Using pastry brush, glaze ham with 1/3 cup maple-bourbon mixture.

Bake ham about 30 minutes until top is lightly caramelized and meat registers 145 F at thickest portion, brushing with remaining glaze every 10 minutes.

Remove from oven and transfer ham

to serving platter. Let rest 15 minutes and garnish with orange slices, orange wedges and rosemary sprigs. (Feature Impact)

The first 500 families will receive one free plant. Additional plants range




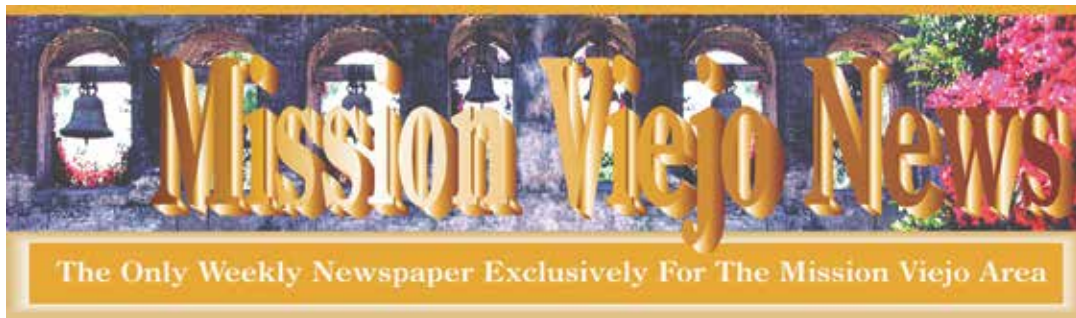

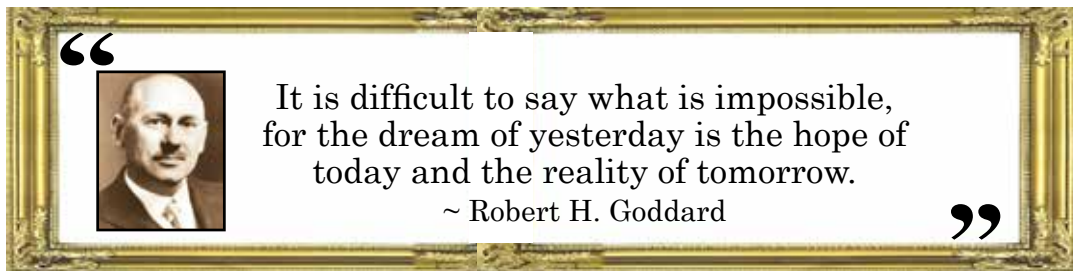

Taste of Wine & Food

PALA CASINO'S ELEMENTA SHINES AS A CULINARY OASIS

At Pala Casino Spa Golf Resort, the energy hits you right away. More than 2,000 slot machines fill a 90,000-square-foot gaming floor, from penny reels to high-limit play, alongside table games including blackjack, baccarat, and Pai Gow Poker. Lights flash and wheels spin, whether you're all in or simply taking it in.

On a recent visit, a short walk from the action revealed a noticeable shift in tone. Elementa feels removed from the casino floor, a quieter space where the focus turns to food, wine, and atmosphere. Inspired by Southern California's natural elements, from desert landscapes to the Pacific Ocean, the restaurant offers an immersive dining experience. Sculptural works by Casey Parlette, including fish, sharks, and an eagle, are woven throughout, adding visual interest without overwhelming the room.

Elementa's foundation is built on a seasoned leadership team. Chef de Cuisine Henri Delahaye brings decades of classical French training shaped by his upbringing near the Basque region of France. He began his culinary career at 17 through a formal apprenticeship and refined his craft under Chef Pierre de Portier at a two-star Michelin restaurant. His background in sauces, seafood, and traditional techniques is evident throughout the menu. After selling his catering business, Delahaye relocated to California, with stops in Rancho Santa Fe and La Jolla, including Bistro du Marché under Chef Jean-Michel Diot. He joined Elementa in 2023.

Sommelier and Room Manager Abraham Marquez and Food and Beverage Director Sarah Jacqlyn round out the experience. Marquez, a San Marcos native with 25 years in wine, blends technical knowledge with a philosophy emphasizing simplicity and balance. Jacqlyn's background spans Estancia La Jolla, Addison, and Omni La Costa, and she continues her WSET Level 3 studies.

Our wine and food journey began with a warm welcome from Food and Beverage Director Sarah Jacqlyn, followed by time with Chef de Cuisine Henri Delahaye and a thoughtful discussion of the wine program with Sommelier Abraham Marquez. Marquez noted that Elementa's cellar includes select legacy inventory from prior programs, with pricing intentionally held steady. One standout was a 2008 Del Dotto Napa Valley Sangiovese, a beautifully expressive wine that set the tone for the evening.

Following bread service, the octopus appetizer arrived perfectly prepared, tender with a clean finish and no trace of a rubbery texture. Accompaniments of chorizo, squid ink sauce, mango, blood orange, and mixed greens created a layered, balanced dish that paired seamlessly with the Sangiovese. Caramelized scallops followed, and as longtime readers know, I am particular when it comes to their preparation. The scallops delivered, with a beautiful sear, a tender interior, and a rich butter sauce that showcased Delahaye's classical French roots.

With the next course, Marquez transitioned to a 2016 Del Dotto Napa Valley Cabernet Sauvignon-dominant Bordeaux to complement a refined rabbit loin entrée. Mild and well-balanced, the dish avoided any gaminess and was served over a polenta round with snap peas, squash, and baby shiitake mushrooms in a mustard-forward sauce that worked beautifully with the wine.

For the main course, a 2012 Nickel & Nickel Rock Cairn Cabernet Sauvignon from Oakville was paired with an 8-ounce ribeye cap from Snake River Farms. Cooked to a precise medium rare, the steak was richly marbled, tender, and deeply flavorful. At the recommendation of our server, Andres Pemberton, both Béarnaise and Cognac au Poivre sauces were added, elevating each bite. A 2005 Conn Creek Cabernet Sauvignon from St. Helena was poured

as a fitting finish to one of the most memorable steak courses in recent memory.

Dessert brought a Pear Delight, featuring pear ice cream, panna cotta shaped like a pear, and pear purée. Marquez concluded the evening with a 1907 D'Oliveiras Madeira, a remarkable and unforgettable final note.

Elementa delivers a refined escape within Pala Casino Spa Golf Resort, where thoughtful cuisine, a deep wine program, and attentive service align. From Chef Delahaye's classical foundation to the leadership of Sarah Jacqlyn, the guidance of Sommelier Abraham Marquez, and the hospitality of server Andres Pemberton, the experience is both polished and refined. More at Elementa.

Easter Dining Around San Diego Easter Sunday brings a range of festive dining options across San Diego. In Del Mar, Glass Box offers an all-you-can-eat brunch from 11 a.m. to 4 p.m. for \$65, blending favorites like omelets, eggs Benedict, and pancakes with Asian-

inspired selections including sushi, fried rice, and robata skewers.

In Rancho Bernardo, Cork & Craft serves an all-you-can-eat brunch from 10 a.m. to 2 p.m. for \$55, featuring sushi, pork belly burnt ends, karaage, and more. Guests can pair their meal with craft beer from Abnormal Beer Co. or add bottomless mimosas for \$10.

For a different take, Omni San Diego Hotel offers a Spring Reset experience beginning with a poolside rooftop workout led by Sylvia Sessions at Tortuga, followed by Easter brunch featuring seasonal dishes, bottomless bubbles, and live bunnies for photo opportunities. Pricing options include \$17.85 for the workout, \$55.20 for brunch with bottomless bubbles, or \$71.21 for the full experience.

Sports fans may gravitate to Hendo's Barrel House, where a buffet from 10 a.m. to 3 p.m. (\$60 for adults, \$19.99 for children) includes brunch staples, a crepe station, and a prime rib carving station.

From the moment guests arrived, there was a buzz of excitement in the air. The cocktail reception offered a lively start to the evening, complete with a silent auction and an impressive array of culinary offerings from some of Southern California's most celebrated chefs. Guests had the chance to mix and mingle while sampling bites from Rich Mead of Farmhouse at Roger's Gardens; Adam Navidi of Oceans and Earth; Ben Martinek of Viamara at The Elwood Club; Kevin Meyer of TGIS Catering; Daniel Hohng of The Park Club; David Martin of The Pacific Club; Shachi Mehra of ADYA; and Jose Angulo of Descanso Restaurant.

The ballroom was beautifully transformed for the dinner and program that followed, creating a sophisticated setting for what was truly a milestone evening. Guests were treated to a multi-course dining experience curated by Chef Kori Sutton, private chef and winner of Hell's Kitchen, whose talent and heart were both evident throughout the night. Sutton shared that food has the power to bring people together, but on this night, it did even more—it helped drive meaningful change for some of Orange County's most vulnerable residents.

The gala's mission was front and center as attendees learned more about Illumination Health + Home and the organization's innovative model of care, which brings together housing, healthcare, and essential support services to help unhoused individuals and families find stability and long-term well-being. Funds raised from the evening will directly support programs that provide medical and behavioral healthcare, case management, access to housing, and wraparound services designed to help people heal, rebuild, and move forward.

Illumination CEO Dr. Pooja Bhalla spoke passionately about the organization's commitment to restoring hope and changing lives, emphasizing that the generosity of the evening's supporters will allow Illumination to continue expanding access to the care families need to grow and thrive. Her remarks reflected the spirit of the night, which was equal parts elegant celebration and powerful call to action.

One of the things that made the gala especially moving was how it highlighted not only the challenges many families face, but also the real solutions Illumination is providing every day. The organization has been redefining care for Orange County's unhoused population through a full continuum of services that stretches from street outreach to permanent supportive housing. Their work is practical, compassionate, and life-changing.

The evening also included special recognition of two outstanding partners whose commitment to the community reflects Illumination's mission. The Bera Family was honored for its multigenerational dedication to education, healthcare access, and community advancement. UniHealth Foundation was also recognized for its continued leadership in improving population health, strengthening the healthcare workforce, and expanding care for underserved communities.

Adding even more excitement to the gala was a live auction and a high-energy closing performance by LIVE 61, featuring Mark McGrath of Sugar Ray and Skip Martin of Kool & the Gang and The Dazz Band. Their performance brought guests to their feet and ended the evening on a joyful, celebratory note.

At a time when habitat loss and climate change are affecting wildlife across California, native plant gardens are becoming an important way for homeowners to support birds, pollinators, and other species.

This year marks the 24th anniversary of the Orange County garden tour, which first began in 2002 as the only local tour dedicated exclusively to California native plants. California In My Garden 2026 continues this proud tradition by showcasing beautifully designed, water-wise landscapes that support pollinators, birds, and other wildlife.

California is home to more species of plants and animals than any other state, and Orange County ranks among its most biologically diverse regions. The gardens featured on the tour offer inspiring examples of how conservation can begin at home. In addition to visiting the gardens, attendees can explore educational and sensory stations along the tour, highlighting the cultural, ecological, and culinary connections to California native plants.

Some gardens on this year's tour highlight innovative design solutions, including rainwater capture systems that channel roof runoff into ponds and swales, mature native trees that provide habitat for nesting birds, and

thoughtfully designed pathways that invite visitors to wander through layered plantings of sagebrush, manzanita, dudleya, and other California natives. Several gardens incorporate water features, shaded seating areas, and creative hardscape elements that demonstrate how native landscapes can be both ecologically functional and visually striking.

"Each garden on the tour tells its own story," said Elizabeth Wallace, co-President of the California Native Plant Society Orange County Chapter. "Visitors will see how homeowners have transformed traditional yards into vibrant native landscapes—capturing rainwater, supporting birds and pollinators, and creating beautiful spaces where conservation truly begins at home."

Garden Tour Committee Chair Irina Ensminger said the tour offers inspiration for gardeners at any stage. "Whether someone is just beginning with native plants or already has a mature garden, visitors will discover creative ideas for bringing California's natural beauty into their own landscapes."

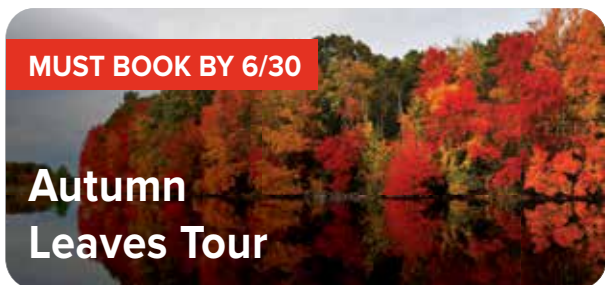

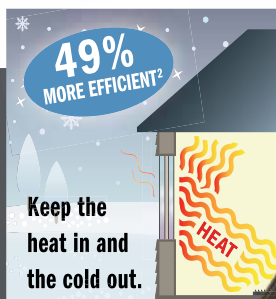
